

Offer Conditions

VoicePortal/SMS-Subscription

1. Scope of application

- 1.1 VoicePortal/SMS-Subscriptions are valid for each EconomyLINE or MultiLINE^{SDN} (including all MultiLINE^{SDN} numbers [MSN] on the same bill).
- 1.2 This offer applies only to telephone connections with no Carrier Preselection (CPS) with another telecommunications provider. By accepting the offer, the customer agrees to telephone exclusively via Swisscom Fixnet.

2. Free SMS messages

- 2.1 The first 30 SMS messages per month are free of charge. Free SMS messages unused by the end of a calendar month cannot be carried over to the next month. SMS messaging in excess of the free SMS messages is subject to standard Swisscom Fixnet rates (see price list at www.swisscom-fixnet.ch/sms).

3. Voice portal

- 3.1 **VoicePortal/SMS-Subscription conditions.** The first 180 minutes per month are free of charge. These free minutes can be used for accessing the voice portal, voice information and entertainment content, and use of the voice portal to set up supplementary telephone services. Free minutes unused at the end of a calendar month cannot be transferred to the next month. Call minutes in excess of free minutes are billed at the standard rate of CHF 0.06 per minute.
- 3.2 **General terms and conditions.** Use of supplementary telephone services (e.g. activation or deactivation of direct call forwarding) is billed at the standard rates valid for the relevant connection type. See price list at www.swisscom-fixnet.ch/zusatzdienste. All prices are inclusive of VAT. Charging is in 10-centime increments. Prices are subject to change without notice.
- 3.3 **SMS and Call Minutes status check, VoicePortal.** A list of sent SMS messages as well as call minutes generated on the voice portal can be viewed online via the "Fixed network bill online" service. It is updated three times a day.

4. Subscription term and termination

- 4.1 The minimum contract term is twelve (12) months.
- 4.2 Customers may cancel a subscription at the end of any calendar month subject to two (2) months' notice but not before the end of the minimum contract term.
- 4.3 If the subscription is cancelled before the minimum contract term, the charges payable until expiry of the period of notice become immediately due.
- 4.4 The subscription is also deemed cancelled should the customer choose another provider or request cancellation of the connection. Swisscom Fixnet is authorized to terminate the subscription, should Carrier Preselection (CPS) be arranged with another provider. Paragraphs 4.1 to 4.3 remain applicable.
- 4.5 Swisscom Fixnet reserves the right to amend or discontinue the offer at any time. Swisscom Fixnet is obligated to advise the customer accordingly of any such amendments. If an amendment to the offer results in significant disadvantages for the customer, the customer shall be entitled to cancel the VoicePortal/SMS-Subscription before the new conditions come into force. The right to cancel before the end of the minimum contract term expires with the coming into force of the changed conditions.
